**PROVISION OF FINANCIAL ASSISTANCE**

The Board announces that on 6 August 2018, Sun Finance, a wholly-owned subsidiary of the Company, as lender entered into the Loan Agreement with the Customer as borrower, pursuant to which Sun Finance has agreed to provide the loan in the amount of HK\$20,000,000 to the Customer for a fixed term of twelve calendar months from the Drawdown Date.

**GEM LISTING RULES IMPLICATIONS**

The grant of the Loan under the Loan Agreement constitutes financial assistance provided by the Company within the meaning of the GEM Listing Rules.

As one or more of the applicable percentage ratios in respect of the Loan exceeds 5% but are less than 25%, the grant of the Loan constitutes a discloseable transaction for the Company under Chapter 19 of the GEM Listing Rules and is subject to notification and announcement requirements pursuant to Chapter 19 of the GEM Listing Rules.

**PROVISION OF FINANCIAL ASSISTANCE**

The Board announces that on 6 August 2018, Sun Finance, a wholly-owned subsidiary of the Company, as lender entered into the Loan Agreement with the Customer as borrower, pursuant to which Sun Finance has agreed to provide the loan in the amount of HK\$20,000,000 to the Customer for a fixed term of twelve calendar months from the Drawdown Date.

## LOAN AGREEMENT

## USE OF THE LOAN

Prior to the entering into of the Loan Agreement, Sun Finance as lender has entered into a loan agreement (the “**Prior Loan Agreement**”) with the Customer on 24 September 2016 for the grant of a loan in the principal amount of HK\$20,000,000 (the “**Prior Loan**”) to the Customer for a term of twelve calendar months commencing from 24 September 2016. The interest rate was 36% per annum and payable monthly in arrears. The loan under the Loan Agreement was used to settle the Prior Loan. No new funding is required from the Group for the provision of the Loan.

## **INFORMATION ON THE CUSTOMER**

The Customer is an existing customer of the Group.

To the best of the knowledge, information and belief of the Directors having made all reasonable enquiries, the Customer is an Independent Third Party.

## **REASONS FOR AND BENEFITS OF THE PROVISION OF THE LOAN**

The Company is an investment holding company. The Group is principally engaged in the provision of equity services, the provision of type 1 (dealing in securities), type 2 (dealing in futures contracts), type 4 (advising on securities), type 5 (advising on futures contracts) and type 9 (asset management) regulated activities under the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) in Hong Kong, and the money lending business.

Sun Finance is a wholly-owned subsidiary of the Company and is a money lender licensed in Hong Kong under the provisions of the Money Lenders Ordinance. Sun Finance conducts money lending business solely in Hong Kong through the provision of unsecured loan and secured loan to its customers, including individuals and corporations.

The terms of the Loan Agreement were negotiated on an arm's length basis between Sun Finance and the Customer with reference to the prevailing market terms. Although the Borrower did not repay the principal amount of the Prior Loan on the expiry of the term of the Prior Loan, she settled almost all the outstanding interest accrued on the Prior Loan and had been in negotiations with Sun Finance for the renewal of the Prior Loan. The Directors are of the view that the terms of the Loan Agreement were entered into on normal commercial terms based on the Group's credit policy. Based on the foregoing and the revenue and cashflow stream from the interest income being expected, the Directors consider that the terms of the Loan Agreement are fair and reasonable and the entering into of the Loan Agreement is in the interests of the Company and its shareholders as a whole.
